

Convex US Terms of Use

This website is owned and operated by Convex North America Insurance Services LLC (“Convex US,” “we” “our,” and “us”).

These terms of use (“**Terms of Use**”) govern your use of any website, application or online service that we own and control and that posts a link to these Terms of Use, including any website or mobile application and any interactive features, widgets, plug-ins, applications, content, downloads and other services that we may make available (collectively, the “**Web Services**”), regardless of how you access or use them, whether via personal computers, mobile devices or otherwise. You agree to waive any and all objections to the exercise of jurisdiction over you by such courts and to venue in such courts.
